To help ensure that all candidates can be given equal consideration, we strongly recommend that the following questions are answered as they relate to the nominee's contributions to his/her community. You will strengthen your nomination by following these instructions.

- List and describe the nominee's specific volunteer activities within his/her home state (where, what, when, how).
- How do the nominee's volunteer activities specifically impact his/her community?
- Why do you feel this individual deserves to be recognized?

Please take the following guidelines into consideration when submitting a nomination form:

- Download the nomination form for Minnesota.
- Complete and return the nomination form by mail or email by the deadline.
- Please limit narrative to no more than 2 pages.
- Any person or organization may nominate a candidate, and may only submit one nomination per year.
