Dear Dr. Steffen,

Thanks to you and your team for taking the time to meet with us yesterday to discuss our concerns with Blue Cross Blue Shield of Minnesota's (BCBS MN) policy with respect to use of modifier 25. As requested, attached is comparative information from the other major health plans in Minnesota. In our previous discussion about this issue, you suggested that the BCBS MN policy was consistent with that of other health plans; the attached information demonstrates that BCBS MN is an outlier in its current modifier 25 payment policy.

On behalf of the MMA, I respectfully request that Blue Cross Blue Shield of Minnesota (BCBS MN) reconsider its policies that reduce payment for evaluation and management (E&M) services when appended with modifier 25.<sup>2, 3, 4</sup>

As we shared in our meeting, the BCBS MN's modifier 25 payment policies impose **redundant** payment cuts to physicians who provide same-day services to your members. The Relative Value Update Committee (RUC) regularly screens all CPT codes that are billed with E/M codes more than 50% of the time and then <u>reduces</u> the relative value units (RVUs) of those codes to prevent duplicate valuation of practice expenses and pre-/post-visit physician work.<sup>5</sup> We agree with your contention that that there are "synergies" and overhead efficiencies generated when services are provided at the time of a patient visit. That, in fact, is what the RUC accounts for in its RVU valuations. The policy of BCBS MN to <u>further</u>, and arbitrarily, reduce payment for these services is inappropriately redundant.

As shown in the attached table, BCBS MN's modifier 25 payment policies are **outliers compared to those of other Minnesota health plans**. Based on publicly available information confirmed by health plan representatives, of Minnesota's seven largest health plans, BCBS MN is the only health plan with modifier 25 payment reduction policies that apply in *all* cases that a modifier 25 is used. Three health plans have no modifier 25 payment reduction policies whatsoever. Three other health plans have modifier 25 payment reduction policies that apply *only* when the E/M service is billed with a same-day preventive service (e.g., CPT codes 99381-99387, 99391-99397). The MMA has confirmed with RUC staff that, although all CPT codes are screened, preventive service codes are billed less commonly with E/M services and, as such, don't meet the current threshold that warrants adjustment for duplication.

The MMA shares the goals of BCBS MN to support high quality, affordable healthcare. The MMA will also advocate for fair and appropriate compensation for physician services. The effect of the current BCBS MN modifier 25 payment policies is to misunderstand the valuation of services done by the RUC and to inappropriately reduce payment for physician-delivered services.
