My only ambition is to make things better. My "area of expertise" beyond dermatology is rural health care. The best compliment I have ever received was from a medical student when she told me, "I want to be just like you."

How Will You Help Advance MMA's Strategic Plan: If I read the four MMA Strategies: Advocate, Engage, Empower and Inform, I've lived all four of them for four decades. My advocacy for patient safety, rural health and other issues spans my entire career. Connection, building trust, community and engagement are key to my leadership tenets and were the core principles of my MMA presidency. Creating physician-leaders is one of my primary goals for

my remaining career years, and one of the main reasons I seek to return to this role. And though communication is ALWAYS a challenge (seven times, seven ways?) I strive to be clear, transparent, authentic, and always honest. I don't think there is any better way to advance the MMA's Strategic Plan or Strategies than to live them.

Why Are you Running for this Position: I am running for re-election as an Alternate Delegate to the AMA representing the Minnesota Medical Association.
